In Interactive Dialogue 3 on "Water for Climate, Resilience, and Environment," joint Co-Chairs, Ms. Yoko Kamikawa, Special Envoy of the Prime Minister of Japan, and the Egyptian Representative, included the establishment of WLD in the recommendations:

"#11: In order to combat climate change, all countries and stakeholders should be united to achieve breakthroughs in urgent water challenges such as the degrading cryosphere, or deteriorating water quality and aquatic ecosystems. Establish symbolic days and years, such as the International Day for Glacier Conservation and World Lake Day, to unite global will and commitments for actions to meet urgent water challenges."

Dr. Rast, Chair of ILEC Scientific Committee, and Dr. Nakamura, ILEC Vice President, participated in UNEP and Indonesian government-hosted side events, presenting the "ILEC Water Action Agenda."

"ILEC Water Action Agenda" Excerpts

"Furthermore, the establishment of World Lakes Day will provide more opportunities for various stakeholder groups to recognize the value of lakes and to promote their activities. As bottom-up approaches and residents' ownership of lakes gradually advance and expand worldwide, sustainable lake management will be realized in which the basin residents play a proactive role rather than being left to only the government."

Facilitated by Dr. Hiroki, a web meeting (Zoom) was held with Minister Baski, Dr. Takemoto, ILEC President, and Dr. Nakamura, during the 2nd Stakeholder Preparatory Meeting of WWF10. The meeting confirmed their mutual collaboration to advance efforts toward establishing WLD at the UNGA.

The Indonesian government called on other governments to support the establishment of WLD, designating it as a day to reflect on the importance of lakes, the degradation of ecosystems, and the urgency of conservation. Furthermore, Shiga Prefecture and Michigan, USA made a presentation about "Lake Biwa Day" and "Michigan Lake Freshwater Week" initiatives. Dr. Takahashi, ILEC Director summarized the importance of strengthening cooperation among lake stakeholders to move towards WLD establishment.
